GENERAL CHARACTERISTICS OF DISTRICT

Nirmal derives its name from the king Nimma Rayudu, who played a pivotal role in the development of the region. In 2016, Nirmal District has been formed as per the Re-Organization of the Districts of Telangana State.

Nirmal district comprises of (03) municipalities, (19) mandals, and (431) villages. The district is situated on the Deccan Plateau comprising fertile lands drained by the Godavari River, that flows along its southern boundary. The district is landlocked; It shares boundaries with Adilabad to the north, Komaram Bheem to the northeast, Mancherial to the east, Jagityal and Nizamabad (along with the Godavari) to the south and Nanded District of Maharashtra to the west.

SWOT OF NIRMAL DISTRICT

Strengths:

- 1) <u>Strategic Location</u>: Nirmal District is at the centre of proposed Hyderabad-Nagpur industrial corridor
- 2) Rich Craft Heritage: District is known for Nirmal painting and toys, which have GI tag
- 3) <u>Agricultural Base</u>: In Telangana, Nirmal has highest cropping intensity as per Socioeconomic survey 2024 and has high production of cotton and soybean, which can support export-oriented agro-industries

Weakness:

- <u>Lack of Industrial Base</u>: Minimal presence of export-oriented manufacturing units.
 Limited large-scale industries to process agricultural or craft products for global markets.
- 2) <u>Inadequate Infrastructure</u>: Insufficient cold storage facilities and warehouses for perishable goods. Lack of modern training centers for artisans to adapt to contemporary designs and global demands.
- 3) <u>Marketing Challenges</u>: Limited digital marketing and e-commerce adoption by local producers and artisans. Poor branding and inadequate participation in recognized trade fairs.

Opportunities:

- 1. <u>Promotion of Handicrafts:</u> Increased demand for eco-friendly and handmade products globally. Government support schemes like ODOP (One District One Product) can boost handicraft exports.
- 2. <u>Agro-Processing Units:</u> Establishing export-oriented cotton ginning, rice mills, maize/turmeric based units and soybean oil extraction units would provide opportunity to increase exports.
- 3. <u>Technology Adoption:</u> Leveraging e-commerce platforms like Amazon and Flipkart for global sales of handicrafts. Use of digital tools to train artisans and farmers in global best practices.

Threats:

- 1. <u>Competition</u>: Stiff competition from other craft hubs in India and abroad offering similar products. Over-dependence on traditional designs could limit global appeal.
- 2. <u>Climate Vulnerability</u>: Dependency on monsoon for agriculture exposes farmers to weather risks, affecting export quality and quantity.
- 3. <u>Middlemen Exploitation</u>: Artisans often lose out on profits due to intermediaries, leading to reduced motivation for export ventures.
- 4. <u>Economic Fluctuations</u>: Changes in global demand due to economic downturns, trade barriers, or currency volatility.
- 5. *Fear psychosis*: Fear of export compliance and payments among people

INTERVENTIONS REQUIRED FOR DISTRICT TO BE EXPORT HUB

Action plan for future recourse

1) Infrastructure Development

- a) Proposal to set up Cotton testing lab in Nirmal District
- b) Tap the potential of Hyderabad Nagpur industrial corridor for efficient exports

2) Quality Enhancement

- a) <u>Standardization</u>: Ensure products meet global standards through certifications like ISO, HACCP, and APEDA approvals
- b) R & D: Collaborate with agricultural universities to improve crop quality and develop export-oriented products

3) Branding and Marketing

- a) <u>Digital Platforms</u>: IIIT Basar & other technical institutes need to be involved to make Nirmal Toys onboard e-commerce activity, diversifying its market base
- b) <u>Trade Fairs</u>: Encourage locals to participate in trade fairs and exhibitions to showcase products

4) Export Promotion Schemes

- a) <u>Government Support</u>: Disseminate schemes like MEIS (Merchandise Exports from India Scheme) and RoDTEP (Remission of Duties and Taxes on Exported Products)
- b) <u>APEDA Assistance</u>: Work with APEDA to access financial support for quality certification, packaging, and export promotion

5) Local Industrial Support

- a) Textile Industry: Develop cotton based units for value-added exports
- b) <u>Agro-Processing Clusters</u>: Establish rice-based product clusters in Nirmal for exportoriented production
- c) <u>Awareness Programs</u>: Organize at least 1 awareness program in each quarter from FY26 in order to diversify cotton related activities and to encourage maize / turmeric processing activities
