DISTRICT EXPORT ACTION PLAN - JOGULAMBA GADWAL DISTRICT

GENERAL CHARACTERISTICS OF DISTRICT

Jogulamba Gadwal is a new district formed on 11 October 2016 in Telangana state, it was previously in erstwhile Mahabubnagar District. The new district has one (01) revenue division.viz., Gadwal with (13) Thirteen mandals and (255) villages. It is the business and education center for the surrounding villages and towns. The District headquarters also has Government Medical college and Hospital.

Gadwal is a city and the district Headquarter of Jogulamba Gadwal district in the Indian state of Telangana. It is located 188 km (117 mi) from the state capital of Hyderabad and is a state assembly constituency. Gadwal historically served as the capital of Gadwal Samsthanam, a vassal of the Nizam of Hyderabad. Gadwal was previously part of the Raichur region of Hyderabad-Karnataka.

Gadwal developed around a fort built by the Gadwal ruler Somanadri, Gadwal Samsthanam, which was a vassal of the Nizam of Hyderabad. It was protected by Mallichetti vamshiyulu. The Nagi Reddy, known today as Nagappa, was an Angarashakulu of Gadwal Samsthanam (Raja Somanadri was a minor). He died in a war with Sultans. Nagappa was succeeded by Narsappa as Gadwal Samsthanam Angarashakulu, but had to leave the palace.


Gadwal Fort is an imposing structure around which the old town sprawls. The fort houses several old temples, the most important of which is Sri Chennakesava Swamy. Another well-known temple, Jammulamma, is located west to the city.

The Priyadarshini Jurala Project is a large dam in Gadwal. It has almost 62 gates, and its generation capacity is 234 MW.

Gadwal is known for its handloom Jarichiralu (Gadwala sarees). It was registered as one of the geographical indication from Telangana by Geographical Indications of Goods (Registration and Protection) Act, 1999. They are most notable for the Zari on the saris. The sari consists of a cotton body with a silk pallu which called Sico saris. The weave is so light that the saree can be packed in a matchbox. For Lord Venkateshwara Tirumala Tirupati Devasthanam (TTD) Bramhotsavam starts with Gadwala-weaved Pattu Vastralu every year.

The District Export Action Plan (DEAP) for Jogulamba Gadwal District is a comprehensive framework designed to harness the district's unique resources, strengths, and potential to contribute to India's export growth. Located in the state of Telangana, Gadwal is known for its abundant natural resources, rich cultural heritage, and diverse economic activities, making it a promising hub for exports.

The primary objective of this DEAP is to identify and promote products and services from Gadwal with significant export potential, develop a supportive ecosystem for exporters, and align district-level initiatives with national and global trade strategies. The plan aims to enhance the district's economic development, generate employment, and achieve sustainable growth through export-led activities.

SWOT OF JOGULAMBA GADWAL DISTRICT

SWOT (STRENGTH, WEAKNESS, OPPORTUNITIES AND THREATS) OF THE DISTRICT

Strengths:

Jogulamba Gadwal District is mostly rural with large geographical area including forest area and consists of good water sources, good land bank and natural resources for setting up of new industries mostly in agro and food based sectors. Gadwal town, located nearly 210 km from Hyderabad is well accessible by Bangalore-Hyderabad National Highway 44. It is also a **Tristate district**, it share borders with Kurnool District of Andhra Pradesh, Raichur District of Karnataka (Telangana, Andhra Pradesh, Karnataka).

Weakness:

- 1) Lack of infrastructure facilities.
- 2) Lack of awareness in exports and also on various interventions of State and Central Governments on export promotion.
- 3) Lack of capacity to compete with traders from major markets.
- 4) Far away from the Capital City Hyderabad.

Opportunities:

- 1) Potential to diversify economic activity through exports.
- 2) Good Scope for establishing export oriented industries.

Threats:

- 1) Lack of standardization of export products, leading to high level of rejection
- 2) Fear psychosis related export compliance and payments among people

STRATEGY TO MAKE THE DISTRICT AS AN EXPORT HUB

- To organize regular meetings with the stake holders of the industry such as awareness camps / seminars / workshops regularly to improve the industry from the production stage to the exporting stage and to provide informative material on various incentives of the Central and State Governments for exports.
- Planned to organize DLEPC meeting at regular intervals under the chairmanship of the
 District Collector with the concerned line departments to enhance logistics and
 infrastructure, and to take measures for better utilization of the existing infrastructure.
- To organize buyer seller meets duly inviting foreign buyers utilizing the government of India schemes atleast on quarterly basis.

INTERVENTIONS REQUIRED FOR DISTRICT TO BE EXPORT HUB

Action plan for future recourse

1) Infrastructure Development

- a) Proposal to set up Cotton testing lab in Jogulamba Gadwal District
- b) Proposal to set up more cold storage facilities through agencies like APEDA, DGFT by involving FPOs to tap the export potential of Groundnut from the District

2) Quality Enhancement

- a) <u>Standardization</u>: Ensure products meet global standards through certifications like ISO, HACCP, and APEDA approvals
- b) R & D: Collaborate with agricultural universities to improve crop quality and develop export-oriented products
- c) Cresting more awareness and encouraging farmers to tap into the export potential.

3) Branding and Marketing

- a) <u>Digital Platforms</u>: Agriculture Universities and other technical institutes need to be involved to make agro products onboard e-commerce activity, diversifying its market base
- b) <u>Trade Fairs</u>: Encourage locals to participate in trade fairs and exhibitions to showcase products

4) Export Promotion Schemes

- a) Government Support: Disseminate schemes like MEIS (Merchandise Exports from India Scheme) and RoDTEP (Remission of Duties and Taxes on Exported Products)
- b) <u>APEDA Assistance</u>: Work with APEDA to access financial support for quality certification, packaging, and export promotion

5) Local Industrial Support

- a) Textile Industry: Develop cotton based units for value-added exports
- b) <u>Agro-Processing Clusters</u>: Establish rice-based and cotton based product clusters in Jogulamba Gadwal for export-oriented production
- c) <u>Awareness Programs</u>: Organize at least 1 awareness program in each quarter from FY26 in order to diversify Groundnut related activities.

SALIENT FEATURES AND CONCLUSION

To make a hassle free export environment in the district Planned to:

- By way of inducing awareness and export process knowledge among the prospective exporters
- Updating the latest export documentation and technical process to be followed by the enterprises
- Making a common single platform at the district level involving all the stake holders
