1.SCENARIO OF HANDLOOMS SECTOR IN YADADRI BHUVANAGIRI DISTRICT

Introduction:

Handloom forms a precious part of the generational legacy and exemplifies the richness and diversity and the artistry of the weavers. Tradition of weaving by hand is a part of the country's cultural ethos. Handloom is unparalleled in its flexibility and versatility, permitting experimentation and encouraging innovation. Creative weavers with their art and artifacts blending the myths, faiths, symbols and imagery provide their fabric an appealing dynamism. The district is well known for 'Ikkat' fabric which has Geo special Tagging and international reputation. The strength of Handlooms lies in introducing innovative designs, which cannot be replicated by the power-loom sector. The handloom industry in the Yadadri-Bhongir district occupies an unique position in the newly formed Telangana State in terms of large coverage, capacity and potential in serving as an important source of livelihood of a fairly large segment of weavers population. The Tie & Dye (Ikkat) pattern of designs are specific for the district. It has a rich and superb heritage of handloom weaving. The artistic skills of the traditional handloom weavers have its own distinctive excellence. The handloom industry is highly labour intensive, with a decentralized set up.

Handloom weaving in the Yadadri-Bhongir district is a traditional occupation of a large segment of weavers population. The weaver communities follow the age-old practice of their ancestors and are normally reluctant to adopt innovations. As a result their earnings from this occupation are paltry and they continue to remain at the tail end of the economic ladder. The weaver's cooperative societies and handloom production centers are key institutions saddled with the responsibility of providing technical, operational, marketing and infrastructural support to the weavers community, in a cooperative framework. In order to promote handloom industry in the district, it has been emphasized to modernize the traditional looms and equipment to enhance operational efficiency and production.

MINUTES OF THE DISTRICT LEVEL EXPORT PROMOTION COMMITTEE (DLEPC) MEETING YADADRI BHUVANAGIRI DISTRICT HELD ON 13.02.2025 AT 11.30 AM. IN PHYSICAL MODE IN THE CHAMBERS OF DISTRICT COLLECTOR, YADADRI BHUVANAGIRI.

The General Manager DIC welcomed all the members to the meeting as the member convener and explained the main objectives and the role of DLEPCs for initiative of "Developing the District into as Export Hub". He explained that the District is well connected by road and railways as it is very near to the Capital city and International Airport. The scope for setting up of new industries is abundant in the Yadadri Bhuvanagiri district as is owing to availability of land resources, skilled youth and excellent infrastructure facilities and proximity to the state capital. Adding to that there are about 1100 Industries in Yadadri bhuvanagiri district which has an investment of 7000 to 7500 Crores providing near about 45000 Direct employment in the district. Apart from that the district has 3 Industrial Parks namely Dandumalkapur Industrial estate which is also know as Green Estate, Industrial Park Bhuvanagiri and Industrial Park Rayaraopet.

The General Manager DIC has further informed that, the main sectors from which currently major exports are made include Bulk drugs and Intermediates and Pharmaceuticals, Hand looms (Ikkat)products. However hand looms sector which supports directly and indirectly to 20,000 weavers and ancillary workers in the district and has great scope for improving exports as these products have Geographical identification for its quality and uniqueness. In view its uniqueness & potential for exports it is identified as the product for promotion of exports under ODOP.

The Deputy Director, Hand looms and Textiles has explained about the importance of the hand looms made in Yadadri Bhuvanagiri District with IKKAT Pattern which has a high potentiality with Tie & Die methodology. She explained that the sector support 6400 Weavers and 12000 Ancillary works in the district has a great scope for improving the exports.

Sri G.Jayashanker, President, Hand loom Weavers Cooperative society, Koyyalagudem has requested the chair to supporting them for availing all benefits available for exporters from concerned departments. He explained that in spite of having potentiality, "Ikkath" fabric is not having expected exports due to lack of working capital / date back design patters, the new generations are not coming in to this activity as it is not remunerative enough, increasing cost of production. due to increased material costs, inadequate credit facilities, lack of R & D facilitates.

Smt .K.V.S.Sailaja ,PPS(Dy.DG)DGFT Hyderabad has explained about the schemes available with the DGFT, Hyderabad. She explained about the *Advance Authorization Scheme*, where Import of raw materials, components, spares, packing materials and others inputs under Advance Authorization exempted from Basic Custom Duty, Additional Customs Duty, Education cess, Antidumping duty and safeguard duty. She also explained about other central schemes which were useful to handloom sector. She has mainly concentrated on creating E-Commerce Platforms for fabric exports and attending International Trade fares for better exposure toward better understanding of the demands and needs of the present markets. She has suggested mainly on Individual Branding-District Branding-State Branding apart from that they also should concentrate on Quality certification of the product for quality assurance. In order to develop the fabric exports the weavers should also concentrate on Product Diversification apart from traditional way of fabric designs and prints.

The District Collector & Chairperson, DLEPC, Yadadri has instructed the Assistant Director, Handlooms and Textiles to interact with and list out the societies / weavers who are currently exporting and who are looking for export, so as to conduct a meeting with them.

The AGM, NABARD has informed that weavers can also use the benefits under Alizone and request the committee members to publicize the scheme. He also stated that weavers are to be facilitated with working capital. Term loan for upgradation of Infrastructure of Handlooms instead of using pit looms weavers should upgrade to Stand looms, He also expressed that all societies are to be brought into functioning by following Co-operatives societies act and motivate all the weavers to join respective society and strengthen them.

The District Collector & Chairperson, DLEPC, Yadadri has instructed the committee members and the concerned Departments to take necessary action to promote exports of Handloom products from the district.

Finally after the deliberations the committee identified the following issues and actions to be taken are as follows.

- 1. As there were no registered exporters, facilitate the societies as well individual to obtain export license with waving of requisite fees. The Handlooms and Textiles department may facilitate in this matter in coordination with DGFT. Telangana.
- 2. Motivating the individual weavers/Societies to market their products through E-Commerce portals like Amazon, Flipkart etc, the Handlooms and Textiles department may facilitate in this issue.
- 3. Steps to be taken for promoting the *Ikkat* brand globally.
- 4. As the societies representatives request, the weavers/societies may be permitted to procure yarn from open market in addition to procure from NHDC.
- 5. Motivating the weavers and societies towards making diversified products like garments and handbags etc, taking the service of NIFT and NID,making the activity remunerable so that the younger generation may continue the profession.
- 6. Motivating them to use organic colours in place of chemical colours which is accepted in the western markets.
- 7. Allowing the weavers to upgrade the stand looms from the existing pit looms which increase the production capacity.
- 8. Provide enough working capital loans with subsidized interest rates.
