### ORDER:

In the reference 2<sup>nd</sup> read above, Government have constituted the District Single Window Clearance Committee for a further period of 2 years with effect from 27-6-2008 under sub section (1) of section (3) of the Andhra Pradesh Industrial single window clearance Act 2002.

- 2. In the reference 3<sup>rd</sup> read above, the Commissioner of Industries has requested the Government to extend the term of the District Single Window Clearance Committee for a period from 27.06.2010 upto 31.03.2015 (coterminous with the Industrial Investment Promotion Policy 2010 -2015), as the term of the Committee expired by 26-6-2010. The Commissioner of Industries has also requested that the Zonal Manager, APIIC of the concerned District be included as a Member in place of representative of APIIC and the General Manager, District Industries Centre as a Member Convener instead of Member of the District Level Single Window Clearance Committee.
- 3. Government after careful consideration of the matter have come to the conclusion that the said committee be constituted under sub-section (1) of Section 3 of the Andhra Pradesh Industrial Single Window Clearance Act, 2002 (Act.No.17 of 2002) for a period from 27-6-2010 upto 31.03.2015.
