ORDER:

In the reference 2nd read above, the Government have constituted the “State Single Window Clearance Committee” for the State of Andhra Pradesh for a period of two years with effect from 27-6-2008 under sub section (1) of section 4 of the Andhra Pradesh Industrial Single Window Clearance Act, 2002

2. In the reference 3rd read above, the Commissioner of Industries has requested the Government to extend the tenure of the State Single Window Clearance Committee for a further period from 27.06.2010 upto 31.03.2015 (coterminous with the Industrial Investment Promotion Policy 2010 -2015), as the tenure of the Committee expired by 26-6-2010.

3. Government after careful consideration of the matter have come to the conclusion that the said committee be constituted under sub-section (1) of Section 4 of the Andhra Pradesh Industrial Single Window Clearance Act, 2002 (Act.No.17 of 2002) for a period from 27-6-2010 upto 31.03.2015.

4. Accordingly, the following Notification shall be published in the Extraordinary issue of the Andhra Pradesh Gazettee dated: 28-01-2011
