ORDER:

In the Government Order 1st read above, Government have issued orders for various incentives/benefits to all eligible new industrial units set up in the State except in the Municipal Corporation limits of Visakhapatnam, Vijayawada and Hyderabad and commence commercial production on or after 01.04.2005 but before 31.03.2010. Projects involving substantial Expansion/ Diversification of existing industries in the eligible lines of activities are also entitled for benefits offered under the Industrial Investment Promotion Policy 2005-2010.

2) In the Government Order 4th read above, Government have issued orders of Extension for the existing cut off date from 31.03.2010 to 31.03.2012 for commencement of commercial production by Mega Projects which are under Pipeline under IIPP 2005-2010, subject to fulfillment of certain conditions.

3) In the Government Order 5th read above, Government have issued orders for Extension of Industrial Investment Promotion Policy for a further period of three months i.e. upto 30.06.2010 or till the new Industrial Policy 2010-15 comes into force, whichever is earlier.

4) The State Investment Promotion Board (SIPB) in its meeting held on 28.06.2010 has decided as follows:-

- To extend the cut off date for fulfilling the Pipeline criteria from 31.03.2010 to 30.06.2010 keeping in view the orders issued extending the Industrial Investment Promotional Policy 2005-10 Policy period from 31.03.2010 to 30.06.2010.

5). The Government after careful examination of the recommendations hereby extend the cutoff date from 31.03.2010 to 30.06.2010 for fulfilling the eligibility Criteria for Pipeline Mega Projects under IIPP 2005-10, subject to the following conditions.

- (1) The unit should achieve its financial closure by 30.06.2010;
- (2) The unit should obtain Environmental Clearance from Ministry of Environment and Forest, Government of India wherever applicable on or before 30.06.2010;
- (3) The unit should obtain Consent for Establishment (CFE) from APPCB on or before 30.06.2010; and

(4) The unit should commence Commercial Production on or before 31.03.2012.

6) The Commissioner of Industries, Andhra Pradesh, Hyderabad shall take necessary action in the matter accordingly.
