## ORDER:

In the letter 5<sup>th</sup> read above, the Chief Executive Officer, M/s. Kirby Building Systems India Limited, Medak District has stated that on withdrawal of 1% concessional rate, effective rate applicable was @12.5%, which now stands revised at 14.5% (with effect from 14<sup>th</sup> January, 2010) and has made them uncompetitive, as other companies are benefiting at 4% sales tax. At the current VAT of 14.5%, their business will become unviable and Kirby may be forced to look for other options of shifting their plant to other location, where the applicable Sales Tax is 4%.

- 2. Government after careful examination in the matter, keeping in view the need to prevent closure of the unit and to protect the existing employment in the backward region of the State, hereby extend the benefit of VAT reimbursement of 10.5% (14.5% 4%) on local sales and inter-State Sales (without 'C'-Forms) to M/s. Kirby Building System India Limited as a special case, for a period of one year prospectively from the date of issue of this order. The amount shall be met from the scheme of Incentives for Industrial Promotion.
- 3. The Commissioner of Industries shall take necessary action accordingly.
- 4. This order issues with the concurrence of the Finance Department vide their U.O.No.5215/201/Exp.I&C/2011, dated 4.6.2011.
