### ORDER:

In this context, to clear all the proposal by December, 2011 and to finalize and sign the MoU during the Summit, Government hereby decided to constitute a Fast Track Project Evaluation Group with the following Members.

- 3. Secretary / Prl Secretary of concerned Department for consideration of any proposal outside the Industries & Commerce Department
- 4. Managing Director, APSFC Limited
- 5. Vice Chairman & Managing Director, APIIC Limited
- 6. CMD, APTRANSCO
- 7. CEO, AP Invest
- 8. Member Secretary, AP Pollution Control Board
- 9. Commissioner of Industries, AP, Hyderabad --- Convenor
- 2. Where proposals pertaining to Industries & Commerce Department are to be considered, the meetings of the Fast Track Project Evaluation Group would be chaired by Vice Chairman & Managing Director, AP Industrial Development Corporation Limited and when the proposals of other Departments are to be considered, the meetings of the Fast Track Project Evaluation Group would be chaired by the Secretary/Principal Secretary to Government of the Department concerned.
- 3. The Group will evaluate the proposals submitted by the interested entrepreneurs. AP Industrial Infrastructure Corporation Limited will be the secretariat to do correspondence with entrepreneurs.
- 4. The Group will send final recommendations to the Government. The Principal Secretary to Government & CIP, Industries & Commerce Department will place these proposals before the State Investment Promotion Committee, and the State Investment Promotion Board to seek final clearances.

### **Time Frame**

- 5. AP Industrial Infrastructure Corporation Limited, will release a press advertisement inviting proposals from the entrepreneurs before 30<sup>th</sup> November, 2011. The Project Evaluation Group will consider the proposals within 15 days from the date of receipt of the same. The proposals recommended by the Group shall be placed before State Investment Promotion Committee / State Investment Promotion Board by the Principal Secretary to Government & Commissioner for Industrial Promotion, within the next 10 days for final clearance. The approximate schedule is as follows:
  - a. Date of advertisement by APIIC Limited by 30th November, 2011
  - b. A time limit of 15-20 days may be specified in the advertisement clearly, so that the entrepreneurs send their proposals in time.
  - c. 1st 20th December, 2011- Fast Track Project Evaluation Group will evaluate the proposals and send firm recommendations to the Government.
  - d. Recommendations of the Group will be considered by the SIPC / SIPB and a final decision will be taken by  $26^{th}$  December, 2011.
  - e. In the following ten days, the draft agreements/Memorandum of Understanding can be finalized taking into account legal and other requirements.
- 6. The Vice Chairman & Managing Director, AP Industrial Infrastructure Corporation Limited, is requested to take further necessary action.
