ORDER:-

In the reference 1st read above, Government issued orders constituting a District Industries Promotion Committee (DIPC) under the Chairmanship of District Collector to deal with the issues pertaining to industries in the respective districts and stipulated that this Committee shall meet every month on a fixed day and proceedings of these meetings shall be furnished to the Commissioner of Industries for review. The decisions taken by this Committee shall be binding on the Officers of various State Government departments at the district level. Non- adherence to the time limits laid down by the Committee by the Departmental Agencies and important problems brought to the notice of the District Collector by Medium and Large Scale Industries should be reported to the Commissioner of Industries.

2. Subsequently, the orders were revised in the reference 2nd read above bringing more functions into the purview of DIPC by expanding its composition.

3. In the reference 4th read above, the Commissioner of Industries reported that the District Administration has an important role in Industrial promotion, employment generation, and nurturing inclusive growth. During, the Review Meeting held on 14-07-2011 with the Heads of the Departments of Industries & Commerce Department, Commissioner of Industries pointed out that there are more than one committee looking into industrial promotion, incentives etc and proposed for merging all Committees into one district level Committee and expanding its functions.

4. It is noticed that over the years, a number of separate committees have been established under the Chairmanship of District for review of Single Window, incentives, task force committee for PMEGP etc. Since the purpose of all these committee relates to the industrial Promotion, there is need to bring all of them under one umbrella of DIPC, including the Government of India Schemes. This would ensure better coordination, integrating and quicker and efficient decision making.

5. In view of the above, Government after careful examination hereby re-constitute District Industries Promotion Committee by merging all the Committees at the district level, under the single umbrella of DIPC and propose the following items for review / monitoring in the DIPC.

- a. To expedite the clearances pertaining to MSMEs as per the time limits prescribed under Single Window Industrial clearances system.
- b. Sanction of Incentives under Industrial Policy as per the limits prescribed from time to time.
- c. Allotment of plots in the Industrial Estates at district level as per the norms fixed by A.P.Industrial Infrastructure Corporation Limited.

- d. To identify suitable Government lands for locating Industrial Estates / Clusters in the Districts and also Assist the major industries for locating suitable land.
 - e. Credit linkage to MSMEs in coordination with Financial Institutions
 - f. To coordinate the activities of all agencies involved in the development of infrastructure for industries in the District and particularly for Small Scale industries.
 - g. Monitoring and promotion of Cluster in the Districts.
 - h. Monitoring and reviewing the progress of PMEGP
 - i. Allotment of Scarce raw materials like Coal, Alcohol etc.,
 - j. To sanction, monitor and review Inclusive Enterprise Development Programme –SC/ST Entrepreneur Assistance Programme.
 - k. To review the incipient sickness of the industry and ensure that the small scale industries are revived
 - l. To act as a forum to hear the grievances of Small Scale Industries units
 - m. Entrepreneurship Development Training / Industrial Promotion Campaigns
 - n. Any other matter relating to enterprise development in the district.

7. The District Industrial Promotion Committee shall invariably hold meetings every month on a fixed date and send a copy of the minutes to the Commissioner of Industries, immediately thereafter.
8. The General Manger, District Industries Centre, the Convener of the DIPC shall begin the meeting with introductory note on the status of industrial development with major issues of concern.

9. The representatives of MSME Associations / Service Societies in Industrial Estates shall be encouraged to participate in the deliberations and contribute to development of enterprises in the district.
