**ORDER:**

In exercise of powers conferred under sub-section (1) of Section 26 of the Telangana State Industrial Project Approval and Self Certification System (TS-iPASS) Act, 2014 (Act No.3 of 2014), Government has issued Telangana State Industrial Project Approval and Self Certification System (TS-iPASS) Rules,2015 vide G.O. 4<sup>th</sup> read above for implementation of the provisions of the said Act.

2. In order to facilitate the investors by providing investor friendly environment, mandate time-bound delivery of all services, Government vide G.O.s 5<sup>th</sup>, 6<sup>th</sup> and 7<sup>th</sup> read above, issued certain amendments to Telangana State Industrial Project Approval and Self Certification System (TS-iPASS) Rules, 2015 issued in G.O. 4<sup>th</sup> read above and brought certain services pertaining to establishment and operation of the Industries.

3. In the reference 8<sup>th</sup> read above, Director of Boilers has requested for the following amendments:

- a) Inclusion of the “Registration of Steam Pipe line” under TS-iPASS
- b) Change of name for the existing service “Renewal of Boilers License” to “Renewal of Boilers Certificate”
- c) Change of time limit for the above service from 7 days to 14 days.

4. In the reference 9<sup>th</sup> read above, CEIG has requested for the following amendments:

- a) Change name of “Electrical Drawing Approval” to “Design Approval” and include it under Approvals for Consent for Establishment.
- b) Inclusion of “Installation certificate” under Approvals for Consent for Operation.
