Government of Telangana is taking several steps for facilitating the methodology for Ease of Doing Business in the State. One of the important aspects here related to this is formulation of Business Regulation (Act / rules / executive orders, etc.), inviting comments from the stakeholders and addressing them while ensuring transparency at each and every step.

2. Accordingly, Government vide G.O.read above, earlier has issued certain orders on guidelines to publish draft Business Regulation online, inviting comments / feedback, addressing the same and publishing the comments / feedback and the view taken by the department along with the final regulations. Provision for the same was enabled which can be seen on the TSIPASS Portal.

3. The Department for Promotion of Industry and Internal Trade (DPIIT ) has communicated State Reform Action Plan(SRAP)-2020 for improving Ease of Doing Business, in which reform number 01, 03,04 & 05 pertain to publishing of draft business regulation online to invite public comments/feedback on the same prior to enactment.

4. Government after careful examination hereby issue the following addendum to include in the additional guidelines to the existing operational guidelines issued vide G.O. read above.

**APPENDED**

The following guidelines shall be appended para (3) of G.O. read above after 3(3):

4. The draft regulations should clearly indicate the law/act/policy under which the regulations are issued, objectives to be achieved and the burden, if any, on the business if the regulations are implemented.
  5. The draft regulations shall be made available for 30 days on the portal on public domain for public to provide feedback
  6. The final approved regulations or license shall be made available in the online wizard/system within 30 days of the approval
5. All the departments/HODs are hereby requested to ensure that these guidelines are strictly followed without any deviation.
