**ORDER:**

In exercise of the powers conferred under sub-section (1) of section 26 of the Telangana Industrial Project Approval and Self Certification System (TG-iPASS) Act, 2014 (Act No.3 of 2014), Government have issued the Telangana Industrial Project Approval and Self Certification System (TG-iPASS) Rules, 2015 vide G.O.3<sup>rd</sup> read above, for implementation of the provisions of the said Act.

2. In order to facilitate the investors by providing investor friendly environment, mandate time-bound delivery of all services, Government vide G.Os 4<sup>th</sup> to 16<sup>th</sup> read above, issued certain amendments to the Telangana Industrial Project Approval and Self Certification System (TG-iPASS) Rules, 2015 issued in the G.O. 3<sup>rd</sup> read above and brought certain services pertaining to establishment and operation of the Industries under TG-iPASS Rules.

3. The Director of Industries, Telangana, Hyderabad, in the letter 19<sup>th</sup> read above has informed that, the Department for Promotion of Industry and Internal Trade (DPIIT) as part of EoDB-2024 ranking has come up with Business Reforms Action Plan (BRAP) with 287 reforms pertaining to 13 Secretariat departments and 26 HoDs. Under this, the following 6 services which are newly included under BRAP-2024 shall be delivered within timelines mandated by Public Service Delivery Guarantee Act i.e. the Telangana Industrial Project Approval and Self Certification System (TG-iPASS) Act, 2014 (Act No.3 of 2014):-

Government after careful examination of the matter, hereby decided to prescribe the timelines for the services provided under the Telangana Industrial Project Approval and Self Certification System (TG-iPASS) Act, 2014 (Act No.3 of 2014), under Business Reforms Action Plan (BRAP), 2024 by amending the Telangana Industrial Project Approval and Self Certification System Rules, 2015 issued in the G.O. 3<sup>rd</sup> read above.

5. Accordingly, the following notification shall be published in an Extraordinary issue of the Telangana Gazette, dated:15.10.2024.

#### NOTIFICATION

In exercise of the powers conferred under sub-section (1) of section 12, sub-section (1) of section 13 and sub-section (1) of section 26 of the Telangana Industrial Project Approval and Self Certification System (TG-iPASS) Act, 2014 (Act No.3 of 2014), the Government hereby make the following amendments to the Telangana Industrial Project Approval and Self Certification System Rules, 2015 issued in G.O.Ms.No.36, Industries and Commerce (IP & INF) Department, dated 17.6.2015, as amended subsequently from time to time.
