The Department of Industrial Policy and Promotion (DIPP), Ministry of Industries & Commerce, Gol has made recommendations on 340 Action Points with respect to Ease of Doing Business. As per the Action Point No. 246 pertaining to "Inspection Reform Enablers", it is mandated to allow for third party certification instead of Departmental inspection under environmental laws for medium risk industries (i.e. Orange Category industries). These Orange Category industries are to be inspected once in five years.

TSPCB has sought proposals from various reputed Institutions / Organizations for third party certification of medium risk industries (Orange Category industries).

In response, the Board has received certain proposals. After examination of the proposals, the Board has decided to empanel the following two Institutions / Organisation subject to Terms of Reference stated below:

- 1) EPTRI, Hyderabad
- 2) IIT, Hyderabad.

Terms of References:

- The list of industries to be inspected will be allocated by the Board in the last week of every month (eg: list of industries for inspection in May will be allocated in the last week of April).
- 2) The observations made during the inspection may be recorded in the "Inspection Format" enclosed and in case of any further recommendations / observations made during the inspection, the same may also be added.

- 3) In case of any objectionable emissions or discharges observed during the inspection, then the stack / ambient air quality monitoring shall be conducted or effluent samples shall be collected at the industry by following the standard procedure. During the sample collection, the signature of the Industry's representative shall be obtained on notice / sample collection form.
- 4) The samples shall be analysed for the following parameters. However, in case of any industry specific parameter(s), the same may also be analysed.

- 5) The Board is proposing computerised allocation of industries for inspection. Once the Module is in-place, the inspecting staff shall enter the date of inspection by logging in Computerized Inspection Allocation module in TSPCB website on the same day of inspection.
- 6) Inspection report shall also be uploaded into "Computerised Inspections Allocation" module within 48 hrs. of inspection.
- 7) Maximum number of inspections in a month will be allotted as per the Institute's proposal submitted to the Board.
- 8) Payment charges for various types of inspections are as follows:

- 9) The institutes shall submit Invoice for charges of inspections carried out by the institute along with Advanced stamped receipt on quarterly basis to the Member Secretary, TSPCB, Sanathnagar, Hyderabad, for making payment.
- 10) The Board will make the payment for the inspections carried out by the Institute on submission of inspection reports with complete information including monitoring reports (in case of monitoring carried out during the inspection).
