**ORDER:**

1. In alignment with the national objectives under the PM Gati Shakti National Master Plan, which aims to enhance multimodal connectivity and infrastructural integration across the country, the institutional framework for establishing robust institutional logistics mechanisms at both State and District levels in Telangana is essential. This initiative is intended to streamline processes, reduce infrastructural redundancies, and enhance the efficiency of logistic operations at the state level and district level thereby boosting the State's overall logistic effectiveness.
2. On the lines of PM Gati Shakti, a State-level portal shall be built to get a comprehensive overview of all the ongoing and planned infrastructure projects at State and District level. This portal shall also include all necessary layers such as special economic zones, utilities, and other key infrastructure details providing a one-stop solution for overall infrastructure development in the State. The portal is equipped with spatial planning tools, real-time satellite imagery, and analytical capabilities to improve coordination among stakeholders and streamline project implementations.
3. The State PM Gati Shakti Portal serves as a unified platform for all infrastructure projects, ensuring that planning, implementation, and monitoring are conducted efficiently. By integrating and synchronising various project phases, the portal significantly reduces time and cost overruns, providing a new trajectory for modern infrastructure development in Telangana.
4. Government, after careful consideration of the matter, hereby decide to constitute the Institutional Framework in line with PM Gati Shakti guidelines at State and Districts Level to streamline processes, reduce infrastructural redundancies, and enhance the efficiency of logistic operations at the state level and district level thereby boosting the State's overall logistic effectiveness.
5. Accordingly, a State Gati Shakti Planning and Coordination Cell shall be formed to ensure comprehensive planning and coordination across the Districts. The Coordination Cell shall be under the chairmanship of Special Chief Secretary/Principal Secretary/Secretary to Government, Industries & Commerce Dept., with the following members:

6. Further, a District Gati Shakti Monitoring Committee shall be formed under the chairmanship of District Collector that shall monitor, review and update the State Government on project progress. The District Gati Shakti Monitoring Committee is as follows:

- Additionally, the District Collector shall have powers to nominate or include any other members as per project needs.

7. Government hereby further direct that, all new infrastructure projects within Telangana both at State and District level must adhere to the following criteria before receiving administrative approval or expenditure sanction:

- All projects must be thoroughly planned, implemented, and monitored using the State's Gati Shakti Portal.
- The portal shall be developed by Telangana State Remote Sensing Applications Centre (TRAC). All departments shall coordinate with TRAC and ensure that their data is integrated into the portal.
- Departments must follow the Standard Operating Procedures (SOP) for data management on the PM Gati Shakti National Master Plan Platform, as issued by the Department for Promotion of Industry and Internal Trade (Logistics Division), Ministry of Commerce & Industry, Government of India. This includes the creation of required GIS layers specific to each project.

- The Industries & Commerce Department, Govt., of Telangana, designated as the Nodal Agency for PM Gati Shakti in the State, will review, and certify that effective planning and necessary layer creation have been completed by the concerned Departments, Public Undertakings, or Agencies. A certificate to this effect must be obtained before submitting any proposal for Governmental administrative approval or expenditure sanction.
- Proposals for new infrastructure projects must include a checklist, as annexed, to seek concurrence from the Finance Department for issuing administrative approval or expenditure sanctions.

8. Further, these guidelines are intended to ensure that Telangana's infrastructure development aligns with the national objectives set by the PM Gati Shakti initiative, promoting a coherent, efficient, and sustainable approach to urban and rural infrastructure development. Additionally, any new infrastructure project must meet the following criteria to be included in the State PM Gati Shakti portal:

- (i) **Capital Outlay:** The project should have a capital outlay of INR 100 crores or more.
- (ii) **Scope and Area of Investment:** The project must involve capital investment in one or more of the following areas:
  - a. Development of logistic nodes such as Inland Container Depots (ICDs), Container Freight Stations (CFS), warehousing, and multimodal or unimodal logistic parks.
  - b. Critical connectivity infrastructure ensures last and first mile connectivity to industrial parks, economic zones, etc.
  - c. Infrastructure supporting multimodal connectivity.
  - d. Development of city logistics plans.
  - e. Digital infrastructure for monitoring freight flows and data management, including the establishment of Gati Shakti data centres.
  - f. New industrial parks including land acquisition.
  - g. Rail-connected cargo terminal projects.
  - h. Projects ensuring continuous freight flow.
  - i. Any other project that deals with logistics or infrastructure.

9. Further, the roles and responsibilities of this coordination cell include but are not limited to the following:

- Develop an integrated master plan for infrastructure projects.
- Identify and prioritize critical infrastructure projects.
- Facilitate the integration of infrastructure networks to avoid duplication and optimize resources.
- Monitor the implementation of the master plan and prepare periodic reports for review.
- Support the implementation of the PM Gati Shakti initiative by providing technical and administrative assistance.
- Assist district collectors in building and developing critical infrastructure on the guidelines of PM Gati Shakti.
  - Develop dashboards for project monitoring and review.

10. Therefore, all the concerned Departments are requested to take further necessary action in the matter accordingly.


