ORDER:

In the G.O. 1st read above, Govt. have issued notification in consonance with Section 54 of the Electricity Act, 2003 and Regulation 43 and 30 of Central Electricity Authority (Measures relating to safety and electric Supply) Regulations, 2010, that "every electrical installation of voltage upto 650V shall be inspected , tested and shall be self- certified by the owner of the installation before commencement of supply or recommencement after shut down for six months and above for ensuring observance of safety measures specified under said regulations and such owner shall submit the report of self-certification in the Form-I or Form-II, as the case may be to the Electrical Inspector." The Installation above 650V are being inspected by the Department of Electrical Inspectorate.

2. Government of India, Department of Industrial Policy and Promotion ("DIPP") through its "Ease of Doing Business - Reform Action Plan 2017" have communicated the following initiatives to be taken up by Electrical Inspectorate Department for simplifying the process of getting Installation Certificate above 650 V being accorded by the Department.

- 1) Design and develop an online system for granting Certification of Electrical Installation above 650 V in a manner that it allows online application submission, payment, document submission and approvals.
- 2) Define clear timelines mandated through the Public Service Delivery Guarantee Act (or equivalent) legislation for approval of complete application for Certification of Electrical Installation above 650 V

3. In accordance with the G.O. 1st read above, and as per the initiative of the Government of India, Electrical Inspectorate Department has developed online system which allows the following:

- Online submission of application for Certification of Electrical Installation
- Online submission of documents and verification without the need for a physical touch point
- Online payment of fees
- Allows the users to download the final signed approval certificate from the online portal

4. In the circumstances reported by Chief Electrical Inspector to Government, and after careful examination as regards to making online for issue of electrical installation certificate of Electrical Installation of above 650V, the Government here by order that under Ease of Doing Business, the functions of department for Certification of Electrical Installation of above 650V shall be online with effect from 01.07.2017 and the applications and documents submitted through online only be accepted and processed.
